FRESH 93.1'S PICK YOUR PURSE CONTEST RULES

THE FRESH 93.1'S PICK YOUR PURSE CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Ontario; and
 - (b) be of the age of majority or older at time of entry in the province of Ontario.
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of Corus Radio Inc., operating as CHAY-FM (the "Station") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "Corus");

 - (d) Any person who has been confirmed as a winner of two (2) Station administered contests within ninety (90) days preceding the Contest start date indicated below where the prize was valued over one thousand Canadian dollars (CDN \$1,000.00); and
 - (e) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 8:00 a.m. Eastern Time ("ET") on March 28, 2024 and ends at 5:30 p.m. ET on April 26, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter online, complete and submit the entry form located at https://931freshradio.ca/contests/ (the "Contest Microsite"). No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.
- 3.5 Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Call. Sponsors assume no liability for entrants not making timely phone calls to the Station due to delays in the streamed signal.
- 3.6 If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined in Section 7 below) will not be liable in any way.

4. PRIZES.

- 4.1 There are thirty (30) prizes (each, a "**Prize**", collectively the "**Prizes**") available to be won by the Prize winners (each, a "**Winner**", collectively the "**Winners**"), each consisting of the following:
 - (a) Twenty-six (26) purses with gift card bundles valued between twenty-five and three hundred fifty Canadian dollars (CDN \$25.00-\$350.00);
 - (b) One (1) purse containing one (1) Fabricare gift card valued at two thousand four hundred Canadian dollars (CDN \$2,400.00) (the "**Fabricare Gift Card**");

- \$100.00) for a total value of three hundred sixty-five Canadian dollars (CDN \$365.00);
- (d) One (1) purse containing two (2) tickets to see Jennifer Lopez on August 3, 2024 at *Scotiabank Arena* in Toronto, ON and a cheque for one hundred Canadian dollars (CDN \$100.00) for a total value of three hundred fifty Canadian dollars (CDN \$350.00); and
- (e) One (1) purse containing two (2) tickets to see Maroon 5 on June 25, 2024 at *Budweiser Stage* in Toronto, ON and a cheque for one hundred Canadian dollars (CDN \$100.00) for a total value of three hundred fifty Canadian dollars (CDN \$350.00).
- 4.2 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.3 The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within two (2) days once such Winners have been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. The Fabricare Gift Card will be limited to two hundred Canadian dollars (CDN \$200.00) per month to be used over twelve (12) months between May 1, 2024 and April 30, 2025.
- 5.2 Winners will be responsible for any other expense not explicitly included in a Prize including but not limited to transportation to and from any Prize, taxes and gratuities.
- 5.3 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.4 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- 5.5 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

6. WINNER SELECTION.

- 6.1 A maximum of thirty (30) Winners shall be selected as follows:
 - (a) Beginning on April 8, 2024 on Monday through Friday the name of two (2) randomly selected entrants will announced by the Station throughout the day (the "**Cue to Call**");
 - (b) Upon hearing the Cue to Call, the selected entrants are invited to call 705-721-4931 (the "Contest Line") within nine (9) minutes and thirty-one (31) seconds;

- (c) The first selected entrant to get through the Contest Line will qualify to select one (1) of thirty (30) numbered "purses" from the wall. Each purse will reveal the description of a Prize. The selected caller will be awarded the Prize as described in the purse chosen as well as the purse selected. **There will be two (2) Cues to Call per weekday;**
- (d) If no selected entrant calls the Contest Line within the allotted time after the Cue to Call, no Prize will be awarded for that Cue to Call and the selected entrants' names shall be entered back into the pool of eligible entrants and may be announced again during the Contest Period; and
- (e) If there are any remaining Prizes at the end of the Contest Period, the Station reserves the right in its sole discretion to execute a blitz on April 26, 2024, after 5:30 p.m. ET to award any unawarded Prizes. The Station will select eligible entrant(s) by a random draw from all eligible entries received during the Contest Period. Each selected entrant will have nine (9) minutes and thirty-one (31) seconds to call the Contest Line to qualify for a chance to win a Prize. This process will continue until all unawarded Prizes are awarded.
- 6.2 Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, each selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
- 6.3 If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The executed Release must be returned within two (2) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach

of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.

The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.

CONDUCT.** By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsite throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. - 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with Fabricare for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.

- 11.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.

The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
