### JUSTIN TIMBERLAKE IN MONTREAL CONTEST RULES

THE JUSTIN TIMBERLAKE IN MONTREAL CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

## 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario;
  - (b) be of the age of majority or older at the time of entry in the province of Ontario; and
  - (c) if selected as Grand Prize Winner (as defined in Section 4.1 below) be legally able to travel to Montreal, Québec (the "**Destination**") between October 4-5, 2024 and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Radio Inc., operating as CKBT-FM, CING-FM, CFHK-FM and CHAY-FM (each a "Station", collectively the "Stations") and their parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Stations, "Corus", the "Sponsors");
  - (b) Employees of Sony Music Entertainment Canada Inc, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "Sony", the "Prize Provider");
  - (c) Any person who has been confirmed as a winner of two (2) Station administered contests within six (6) months preceding the Contest start date indicated below where the prize was valued over one hundred fifty Canadian dollars (CDN \$150.00); and
  - (d) The household members of any of the parties listed in Section (a) to (c) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 12:00 a.m. Eastern Time ("ET") on March 25, 2024 and ends at 11:59 p.m. ET on April 5, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

### 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter, listen to a Station Monday through Friday (excluding statutory holidays), between 5:30 a.m. and 12:00 a.m. ET for each unique code word (each a "Code") to be announced. Upon hearing each Code, listeners are invited to visit one of <a href="https://915thebeat.com">https://915thebeat.com</a>, <a href="https://931freshradio.ca">https://931freshradio.ca</a> or <a href="https://energy953radio.ca">https://energy953radio.ca</a> (collectively the "Contest Microsite"). No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per Code. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

# 4. PRIZES.

- 4.1 There is one (1) grand prize (the "Grand Prize") available to be won by the Grand Prize winner (the "Grand Prize Winner") consisting of a trip for two (2) to the Destination which shall include:
  - (a) One (1) night hotel accommodation at a hotel or such other venue to be selected by the Sponsors in their sole discretion for the Grand Prize Winner and Guest based on double occupancy unless otherwise indicated;
  - (b) Two (2) tickets to see Justin Timberlake on October 4, 2024 at the Bell Centre at the Destination;
  - (c) One (1) vinyl copy of Justin Timberlake's new album; and
  - (d) Five hundred Canadian dollars (CDN \$500.00).
- 4.2 The Grand Prize has an approximate value of one thousand four hundred Canadian dollars (CDN \$1,400.00). Actual value of Prize will depend on departure city.
- 4.3 There are four (4) secondary prizes (each a "Secondary Prize", collectively the "Secondary Prizes") available to be won by the Secondary Prize winners (each a "Secondary Prize Winner",

- collectively the "Secondary Prize Winners") each consisting of one (1) vinyl copy of Justin Timberlake's new album. Each Secondary Prize has an approximate value of forty-five Canadian dollars (CDN \$45.00).
- 4.4 Grand Prize and Secondary Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner and Secondary Prize Winners are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.5 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.6 Prizes will be distributed within thirty (30) days after each Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

### 5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Grand Prize Winner and their Guest must be available to participate in the Grand Prize from October 4, 2024 through October 5, 2024. Should Grand Prize Winner and/or Guest be unable to participate on the dates and times designated by the Sponsors, the Grand Prize will be forfeited and awarded to an alternate winner.
- 5.2 Grand Prize Winner and Guest will be responsible for any other expense not explicitly included in the Grand Prize including but not limited to transportation to and from originating and Destination airport, transportation to and from any Grand Prize related events, travel and medical insurance, travel documentation, airport improvement fees, bag check fees, taxes, gratuities, telephone calls, and in-room charges. Grand Prize Winner may be required to present a valid major credit card upon check-in at the hotel to cover any expenses over and above the standard room charge.
- 5.3 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.4 In the event that the concert is cancelled for any reason whatsoever, that portion of the Grand Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- 5.5 Guest must: (i) be of the age of majority or older in their province or territory of residence; (ii) be legally able to travel to the Destination and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (iii) comply with the Contest Rules and sign and return the Release (described in Section 7 below).
- 5.6 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.7 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

### 6. WINNER SELECTION.

- 6.1 One (1) Grand Prize Winner shall be selected as follows:
  - (a) On or about April 8, 2024 in Kitchener, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Grand Prize Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release.
- 6.2 Four (4) Secondary Prize Winners shall be selected as follows:
  - (a) On or about April 8, 2024 in Kitchener, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period from each Station. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by each Station. Before being declared a Secondary Prize Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release.
- 6.3 THE SELECTED ENTRANTS WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN APRIL 8, 2024 AT 12:00 P.M. ET AND MUST RESPOND WITHIN THREE (3) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrants must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If a selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- 6.4 If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The executed Release must be returned within five (5) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.

The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.
- 10. **CONDUCT.** By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at each Contest Microsite throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Microsite or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person.
